

# PLEASANT HOPE A+ SCHOOLS AGREEMENT

All eligible students at Pleasant Hope High School, regardless of income, who meet all the criteria listed below have the opportunity to receive reimbursement for the unpaid balance of the cost of tuition and general fees, subject to legislative appropriation, for a period of 48 months after high school; completion of 105% of the hours required for the program; or receipt of an associate's degree to any Missouri public community college, vocational or technical school after federal post-secondary financial assistance funds have been applied. This is contingent upon the student meeting **ALL** of the following requirements:

1. Attend a designated A+ School for three years prior to high school graduation.
2. Graduated from a high school with a GPA of **2.5** or higher, for the four-year period.
3. Maintain at least a **95%** attendance record for the four-year period.
4. Performed **50** hours of unpaid tutoring or mentoring for other students of which **25% may include job shadowing**.
5. Maintained a record of **good citizenship** and avoidance of the unlawful use of drugs and/or alcohol.
6. Make a documented, good faith effort to secure all available federal post-secondary student financial assistance funds that do not require repayment (by filling out a FAFSA form after October 1st of the students senior year).
7. Male students must register for selective service and show proof of such registration. Failure to do so could jeopardize the student's eligibility to receive A+ funds.
8. Beginning with the class of 2018, students must pass the Algebra I EOC **advanced or proficient**; or by achieving a combined ACT math subscore and high school GPA in accordance with the scale that can be found at: <https://dhe.mo.gov/ppc/grants/aplusscholarship.php>

The student's financial incentive will be available for a period of **48 months** after high school graduation; completion of 105% of the hours required for the program; or receipt of an associate's degree for a qualifying student and covers the cost of tuition and general fees, subject to legislative appropriation.

*Agreement: I have read and understood that if I successfully meet the above criteria, the State of MO may provide reimbursement for the cost of tuition and general fees, subject to legislative appropriation, for a period of 48 months after high school; completion of 105% of the hours required for the program; or a receipt of an associate's degree to any MO public community college, vocational or technical school. I have been informed of the conditions for eligibility and understand the criteria as they apply to the A+ School Financial incentives outlined in the A+ Schools Program.*
